PIONEER WAY dueled, between horses stretch, weakened. CHELSEA'S KITTY dueled inside, gave way. INDY CUE allowed to settle, flattened out. PROPERLY GRAY off slowly, no threat. VERY SPECIAL ANGEL allowed to settle, faded. LA GRAEME good position, tired.
