MR SLEW BAR dueled from the outside for the early lead, remained engaged through the turn, shook loose at the eighth pole to open a clear margin and proved best while kept to task. XTRA SPICY dueled from between foes for the early lead, remained engaged with the winner entering the drive, held a forward position through the drive but could not match strides. BULLERINA KID stalked the early pace from the inside, advanced entering the turn along the rail, altered outside for the drive and was gaining late. SOUTH TULSA COUNTY dueled from the inside for the early lead, battled through the turn but could not keep pace. SAUNA BOY could only improve position. BELCHERVILLE went evenly. ANNA'S STRAWBERRY pressed the early pace inside and tired. B ART TWO was no factor. DANDY DIAMOND was no threat. ROMANTIC NICK hit the gate at the start and was outrun.
