BIG BUCK BAYLOR dueled inside, went clear late and lasted. FRONT LINE LAWYER was unrushed early between rivals, rallied four wide at the top of the stretch and missed. CORNISH ROSE dueled outside of the winner and gave way late. INDY BRASS stalked the pace three wide and then had a mild late bid. BARRADO raced evenly inside. I REPENT saved ground to no avail. MAJOR KASH and CLEAR CREEK improved positions late. CLEARLY N THE LEAD was through early. SAUNA BOY was not a factor. MAJOR APPEAL and BOIS D'ARC FOREST stalked the pace for a half mile before giving way.
