WHIRLING CREST improved position late inside. COALTRAINS FLAME vied inside before giving way in the drive. P L CLASSIC RIVER vied five wide, then gave way in the drive. LINCOLN COUNTY was not a factor. DEMON'S DEVILLE saved ground to no avail. CEEYA SAM was not a factor. U F O DETECTED pressed the pace four wide to the far turn, then faded.
