R. C. QUE stalked pace, between horses gained command turn, driving. KEKELO bumped, allowed to settle, 5 wide stretch,closed fast,second best. WHIRLING CREST good position, between horses, 4 wide stretch, flattened out. DANIEL'S BIG D set pace, 3 wide, failed to sustain bid, weakened. OZARK MINISTER bumped, rushed to contention, gave way. MAMMOTH STORM slow early, 5 wide into stretch, passed tiring rivals. LAFFER'S ECHO close up, inside, faded. PIGINTHESKY broke out, bothered foe, evenly. CAT FLASH no threat, failed to menace. JO POWER squeezed start, no threat. CRAFTS BY GENE lugged in start, brief speed. TRICKIE AURIUM pinched back start, failed to menace.
