HAYMOW BOB stalked the pace four wide, rallied at the quarter pole and was clear late under a steady drive. S C KING stalked the pace four wide, bid late but was no match for the winner. YOGA was squeezed back at the start, then bid late seven wide. DEFENDER'S WORD saved ground to no avail. CIRCUSTOWN CAT pressed the early pace before giving way. PIE FACE dueled, went clear in the stretch, then gave way. COMMAND CAT was not a factor. NEW DEAL passed tired rivals. JUDGE BLACK and DAT DOE DILBERT vied early outside. WHISKEY AND WOMEN was through early outside. UP THE CREEK stumbled at the start.
