SEQUOIA CHARM void early speed, 5 wide stretch, full of run, up in final stride. B B QUEEN OF SCAT allowed to settle, between horses turn, closed fast, just missed. BORDER SLEW good position, 4 wide stretch, late rally. MISS SILVER RIDGE close up, gained command stretch, weakened. ENCHANTED MESA close up, gave way. CATAGUSKA well placed, faded. SHER'S FAN TA Z set pace, tired. COOLMON KITTY well placed, stopped.
