SEA YA WAGER was near the pace on the turn, lodged her bid in upper stretch and drew clear late. SOLSTICE MOON was a bit rank into the turn, inherited the lead on the turn then couldn't match strides the final furlong. VIA CARI saved ground on the turn, stayed inside for the stretch and weakened late. CHULLO'S ARIANA was well placed into the turn, was four wide into the stretch and lacked a solid bid. MADAM HOUSESPEAKER was three deep into the turn, was five wide into the stretch and lacked a bid. MISS MIDGET couldn't keep up with the pace early, moved inside and could only pass tiring foes. GEISHA GHOST was on the lead while off the rail then bolted midway on the turn and lost all chance. SADILADY took the three path into the turn with the rider losing his whip midway on the turn and didn't seriously threaten. AWESOME QUEEN hesitated briefly at the break, was five wide into the stretch and was not a factor. RIPPIN PIPPA took the three path much of the way but was never a factor.
