REDS FLING was rated while never far back, split foes moving into the stretch then wore down the leader in the closing strides. MISSINGRBUENO was three deep contesting the pace, took a clear lead on the turn, resisted when challenged and held on well to the finish. KIDEEAKEY was five deep near the quarter pole, lodged his bid in upper stretch but wasn't good enough. NOT A BULL was four deep near the quarter pole, dropped back some in upper stretch then came again and was gaining in the late stages. LOUISIANA LAWYER forced the pace from between foes,, remained a threat to mid-stretch then weakened late. COOL AUTUMN was reluctant to load, forced the pace from the rail then gave way through the stretch.
