ARIZONA'S GOLDEN vied for the lead and dueled throughout, came in some near the sixteenth pole, brushed a rival and held sway at the finish. FANTABULOUS M Q vied for the lead, dueled inside the winner then was brushed near the sixteenth pole and wasn't good enough. LEGACY NORTH settled after the start, was five wide into the stretch and finished willingly. SAN RAFAEL SWELL settled after the start, took the two path into the stretch and lacked a solid bid. POTEEN'S CAT was just off the leaders to the turn, took the three path on the turn and lacked a rally. BROKEN HABIT forced the early pace, was four wide on the turn and tired in the stretch. TEARS IN MY BEER saved ground to no avail. SNOWBOUND FIREGIRL lagged after the start and trailed. After a stewards inquiry and a claim of foul by the rider and trainer of FANTABULOUS MQ against the winner for alleged interference near the sixteenth pole, ARIZONA'S GOLDEN was disqualified and placed second. This race was hand timed.
