COUNTY WEXFORD stalked the pace setter to the stretch, lodged her bid in upper stretch then drove clear late. HI FLYIN STORM set the pace, responded when challenged in the stretch and began to weaken late but held the place. SHEMA REEF was three wide to the turn, was asked midway on the turn, came four wide into the stretch and finished willingly. BUCK'S BOUNTY was just off the pace along the rail into the turn, saved ground to the stretch, stayed along the rail in the stretch and weakened. SPRINGVEE took the three path into the stretch but never seriously threatened and trailed throughout.
