PHONE ANALYST vied for the lead while four wide to the turn, took a short lead inside the three-eighths marker, was four wide while clear into the stretch and held off late challengers. BEAUDACIOUS LADY was slow to load, saved ground to the stretch, stayed inside to mid stretch, eased out to the four path and finished well. MUDDER OF PEARL was just off the leaders into the turn while in the two path into the turn, was four wide into the stretch and finished willingly. COUNTY WEXFORD led from between foes near the half-mile marker, was still between foes into the stretch while in contention then weakened late. FANTABULOUS M Q saved ground on the turn, stayed inside for the stretch and weakened. SHE'S ALL REV'D UP stumbled slightly at the break, was five wide into the stretch but trailed throughout.
