**Footnotes**

TIZ IN COURT was allowed to settle early five wide, sustained a bid to close mid track in the stretch and inched away. OCEANOR showed early speed drawing clear, was challenged in deep stretch, went evenly late but held the place. SMOLDER prompted the early pace from the outside, angled in near the eighth pole and lacked a gain late. MILLER'S TIME was unhurried early four wide, made a move mid way then came up empty in the stretch. LAVA SHOW was forwardly placed early four wide between foes then weakened. I THINK IT IS was outrun early racing off the inside, spilt foes in the turn and placed a mild bid. FRANKSASSESEDVALU was within striking distance early between rivals four wide then gave way. D E HIGH COURT was off slow early racing along the inside and lacked a closing response. FLEETING SUMMER was well back early racing wide and was not a factor. TOOLATE AGAIN SAM retreated steadily along the inside.
