### Footnotes

RED TAPPER was off slow early, moved up steadily five wide, was on even terms at the eighth pole, dueled to the wire drifting in some, bumped A GHOST BY CHOICE leaving the sixteenth pole then inched away. A GHOST BY CHOICE outrun early three wide, loomed up four wide into the second turn, drifted out at the top of the stretch, dueled into deep stretch, was bumped near the sixteenth pole and outfinished. JACK THE TERAS was unhurried early racing five wide, gained steadily then drifted in through the stretch. MAKENNA'S GOLD set the early pace saving ground then weakened in the drive. FIRST JOURNEY was forwardly placed early, went four wide in the stretch and gave way. SQUATTY BOB prompted the early pace while saving ground and was finished early. TIO TIO showed little in a dull effort. CATRON COUNTY retreated steadily. There was a Stewards Inquiry and also the rider of A GHOST BY CHOICE claimed interference against the rider of RED TAPPER and after reviewing the films it was determined that RED TAPPER would be disqualified and placed second for interference in the stretch.
