GOSSIP DOME came four wide, fought gamely in the stretch but could not match strides with winner and was denied. SOARING DEA came five wide and rallied for show. DESERT AVENUE bid five to six wide and finished evenly. LADY PIRATE sustained a mild late bid inside. WHISPER'S SISTER was back early, circled the field and had no response. PULPIT ACCOUNT stalked the early leader and faltered. The rider of the #8 claimed an objection against the rider of the #4. After a Steward's review there was no change.
