AFRICAN ROSE forced the early pace four wide, rallied in the stretch, was no match for the winner but clearly the best of the rest. MY LILLY was allowed to settle early racing off the inside, placed a bid three wide and gained the show. SOPHISTICATED pressed the early pace from the outside then weakened. ANGRY BIRD was unhurried early while saving ground, lugged out into the stretch, was taken up and eased to the wire.
