Footnotes

LA RITA chased the early leaders six wide, sustained a bid at the top of the stretch, was urged steadily to be on even terms with the leader then inched away to prove best. GHOSTLY BREW broke sharp to set the early pace racing four wide, was challenged into the stretch, then dueled to nearing the wire with a good effort but missed in the final strides. GHOST OF SCOTLAND was off slow early, raced wide throughout and showed some effort late to gain the show. BELLE OF ABO pressed the early pace five wide, was finished early and weakened into the stretch. ROAD TIME was allowed to settle early saving ground and lacked a late response. ROWDY SKIES was unhurried early, went seven wide and retreated steadily.
