THAT'S WHO pressed the early pace three wide, sustained a bid to gained the lead then drew clear in the stretch and held the advantage. HONSHU CITY was allowed to settle early saving ground, began to rally angling out four wide and was gaining late. T. V. STEVIE set a pressured early pace from between rivals, was challenged into the turn then weakened but was able to hold the show. LEGAL STORM prompted the early pace five wide, loomed up in the turn to be within contention then flattened in the lane. E BAR WAY was off slow early, saved ground throughout and sustained a steady effort. DUELING DOM was forwardly placed along the rail, angled five wide and lacked a gain. RUSSIANONTHERAIL was outrun early, went six wide and placed a mild bid. SAPELLO LARUE was within striking distance early, went five wide and lacked a late effort. I DO MY OWN TRICKS was void of early speed and lacked a late response. MR. WIZARD was never far back early, then faded steadily four wide. BOY EGO retreated steadily five wide.
