SHAMROCK GIRL drew quickly clear racing off the rail, was never challenged and proved to be the best. GO TO GOLD chased the early leader four wide, fought for the place in deep stretch to prevail but was not a threat to the winner. A PENNY LANE was unhurried early, rallied along the rail, altered outward near the eighth pole to be outfinished for the place. DRIVING MISS DOM was off slow early saving ground, began to close the gap in the turn then went evenly in deep stretch. DAWN TERA was forwardly placed early four wide then weakened. STORMIN BOMB raced mid pack three wide, faded in the stretch and was vanned off. VOWSMAKEMEBLUSH was off slow early racing off the rail, lugged out in the turn and gave way. STORMY CANYON failed to threaten.
