### Footnotes

PLEA AGREEMENT was allowed to settle early saving ground, angled out four wide in the stretch, closed well, dug in final strides and prevailed. PIERRE BEAR set the early pace drawing clear down the backstretch, drifted three wide at the three sixteenth, was challenged nearing the wire, fought gamely but missed in the yards. SMOLDER was unhurried early saving ground, angled out three wide, finished with urging and was along for the show. HIDDEN RECIPE chased the early leader saving ground and was finished after a half. JACK CARTER was never far back early, went five wide at the three sixteenths then gave way in the stretch.
