Footnotes

TICO'S STUDENT advanced between horses, waited for room behind the early speed on the bend, split rivals two wide at the top of the stretch and was driven clear the last eighth. YOURARIDER advanced from outside to vie for the lead four wide on the turn, battled for second the last eighth and edged ahead of SERENA MORENA. The latter chased the early speed from outside, went for the lead three wide on the bend, battled into the last furlong, was no match for TICO'S STUDENT, fought gamely for second but did not have enough late. BARCELONA BABE without speed between horses, came three wide into the stretch and steadily improved position without threatening. TO TERAS DANCER progressed between horses early, moved to the inside on the turn and advanced with BARCELONA BABE through the stretch. BARGAIN TABLE raced closest to the early speed from between rivals, gained a slight advantage two wide on the bend, had the inside entering the lane, began to back up, altered outside upper stretch and continued to fade. DEBS PURPLE ROBYN trailed, picked up her pace from outside taking the bend, lost ground fanning to path eight into the stretch, progressed to the eighth pole then leveled off. NITA'S GONE WILD ran in midpack between horses, in path four on the turn, drifted out some into the lane and flattened. ICED showed no speed, backed up from path three taking the bend and had no stretch bid. RED'S LASS quickly sprinted clear but faded along the rail leaving the turn. BELLE OF WALTERS was soon well back, improved position four wide on the turn, swung out entering the lane, was steadied briefly behind NITA'S GONE WILD, angled out some and had no late bid. ROLLIN ROCKETS was also soon well back, checked when her path along the rail was taken by TO TERAS

DANCER and had little to offer the rest of the way.
