ESSENCE HIT MAN set a pressured pace, moved clear into the stretch, came out midstretch when hit right-handed in midstretch but held under a steady drive. DIMENSION (GB) stalked the pace, chased hard on the turn, finished under a determined drive, was gaining late but missed. PASO DOBLE stalked the pace, came three and four-wide through the turn, chased into the stretch but evened out in the late stages. CONSOLIDATOR JOE settled off the pace, chased three-wide on the turn but never reached contention. BEAR TOUGH TIGER pressed the pace, chased hard late turn but evened out in the final furlong. COURT OF THE REALM settled off the pace, chased on the turn but lacked a response in the stretch. A CLAIM OF FOUL LODGED BY THE RIDER ON DIMENSION (GB) AGAINST ESSENCE HIT MAN FOR INTERFERENCE IN THE STRETCH WAS DISALLOWED.
