### Footnotes

SET HUT bumped lightly with a rival at the start, raced inside on the first turn, set the pace, vied in the two path on the far turn, was asked at the top of the stretch, responded well in the drive and proved best under steady urging. IDA'S WARRIOR bumped with a rival at the start, raced in the two path on the first turn, settled just off the pace, made a bid while four then three wide on the far turn, lost touch with the winner under a drive in upper stretch and was outfinished while well clear for the place. ROLLWITHIT raced in the two path on the first turn, lagged at the rear of the field, moved out while advancing around the half-mile pole, was ridden along in the four path on the far turn, drifted inward in upper stretch and came up empty while best of the rest. COUNTRY LAWYER bumped with a rival at the start, raced in the two path on the first turn, tracked the pace, was urged along while two to three wide on the far turn, bobbed outside the quarter-pole and capitulated. CASH FIRST bumped with a foe at the start, went four wide on the first turn, settled on the outside under some urging, was forced out near the half-mile pole, dropped in leaving the backstretch, raced three then two wide on the far turn and failed to respond. AT MY SIGNAL bumped lightly with an opponent at the start, saved ground on the first turn, was reserved on the inside, moved closer near the half-mile pole, was urged along while inside on the far turn and had nothing left. THUNDER ALLEY bumped with a foe at the start, went three then two wide on the first turn, settled off the pace, was urged along while near the inside early on the far turn, moved to the three path before the quarter-pole and faltered. THEY CALL ME SEB went three wide on the first turn, settled on the outside, was carried out near the half-mile pole, dropped back fast in the four path on the far turn and faltered then was eased in the stretch but walked off.
