GYPSY ROBIN prompted the early issue under a rating hold, moved to the front three wide passing the quarter pole, moved inward into the lane and drew clear then responded to left handed pressure and edged clear again while holding a rival safe. SAY A NOVENA between rivals into the turn, lodged a three wide bid turning for home and chased the top one then finished willingly while second best. SELECT CAT broke a bit slowly, saved ground and advanced turning for home then lacked the needed stretch response. COLORMESAICHI trailed and inside into the turn, raced off the rail into the stretch and lacked a rally. CLARESMIEZIE bobbled some and broke outward, raced up close and four wide on the turn, drifted in some entering the lane and lacked a bid. VUKOVAR a bit slow into stride, moved up inside to reach the front, raced in the two path on the turn and tired through the lane.
