A supplemental nomination fee of \$500 in addition to the entry fee will be accepted at any time prior to entry. All starters including supplemental nominees will receive a \$750 rebate. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. Three Year Olds 119 lbs. Older 123 lbs. Non-winners of \$40,000 at a mile or over on the turf in 2012 allowed 3 lbs.; three races on the turf, 5 lbs. (Maiden, claiming, starter and restricted allowance races not considered in allowances). The New York Racing Association reserves the right to transfer this race to the Main Track. A presentation will be made to the winning owner.

SWIFT WARRIOR tracked YIELD BOGEY while sitting a loose pocket during the initial stages, was tipped outward into the three path near the end of the backstretch, ranged up towards the front runners primarily under his own power during the later stages of the run around the far turn, turned for home well within striking distance and got called upon, offered a good response without hesitation, was just short of achieving the top at the end of the furlong grounds, grabbed away the lead in short order and edged away steadily, finishing the race hand urged. HOOFIT (NZ) saved ground until the eighth pole, was angled outward and positioned outside the front runners, came home willingly to get up late for the place. YIELD BOGEY broke alertly, established control and tucked along the rail, doing the latter two with time to spare before leaving the homestretch, rated kindly on an open lead until the quarter pole, came under intensified pressure and was soon cut loose, desperately clung to the slimmest of leads arriving at the furlong marker, yielded soon afterwards then weakened enough in deep stretch to have to settle for show honors. BEAU CHOIX settled into the midpack from off the inside, was taken in hand for a stride as the winner was maneuvering his way into the three path in the vicinity of the half mile pole, went on a little further and got asked for some run, held on willingly after entering the stretch to grab the last major check. NINE O WONDERFUL was unhurried while along the outside for the opening six furlongs, made little progress during the initial portion of the stretch drive, was taken in hand, pausing briefly in traffic coming to the eighth pole, altered course a

couple of lanes for optimal clearance, kicked in with good, but belatedly foot. RIGHT ONE (FR) in the two path, failed to apply any serious pressure on the early pacesetter, was asked for a response by the five-sixteenths marker with the same result, tired steadily once through the furlong grounds. PARIS VEGAS three wide and set down at the five-sixteenths pole, made no headway on the front runners. SCOTUS took the inside route until upper stretch, was never involved. PERFECT FOOTPRINT leapt up at the break, getting away last as a result, darted over to the inside and judiciously took the shortest way around the opening turn, was swung outward early down the backstretch, failed to reach a contending position.
