FOR THREE-YEAR-OLDS AND UPWARD. Free nomination, \$250 to pass the entry box and \$250 additional to start.

Supplementary nominations may be made by 12:00 PM Friday, August 4, 2017 by payment of \$2,500 (includes entry and starting fees). \$50,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth Weights to be announced Saturday, August 5, 2017. Starters to be named through the entry box by the usual time of closing. In the event this race is not divided it will be limited to 12 starters. Highweights preferred. In the case of ties, second preference to start will be given to those horses having accumulated the highest earnings in 2016-2017. A trophy will be presented to the winning owner. Nominations closed Saturday, July 29th, 2017 with 33 nominees. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One mile out of the chute.) (Rail at 24 feet).

FLATLINED settled in hand, took closer order through the second turn, angled out for the final furlong, closed with a rush and was up in the final strides. ONE MEAN MAN tracked three wide, fought doggedly between horses but was unable to resist the winner. ONE GO ALL GO veered in at the start, recovered quick and opened clear to dictate terms, battled gamely but grudgingly gave in. PLEUVEN (FR) settled in hand, tucked in to save ground, advanced between horses, angled out and loomed large but flattened during the drive. FLASHY CHELSEY was close up toward the inside, continued on willingly but was caught in tight late. ADVENTIST was unhurried, angled out and finished with a belated gain. RACER contended four wide, but faltered entering the stretch and retreated. HAWAAKOM was unhurried into stride and lacked a response when called upon.
