All fees to be paid to the Horsemen's Bookkeeper prior to the start of the race. \$200,000 guaranteed, with 60 percent to the winning owner, 20 percent to second, 11 percent to third, 6 percent to fourth and 3 percent to fifth. WEIGHTS, SATURDAY, APRIL 13, 2013. NOTE: This stakes will be limited to fourteen starters. Highweights (including scale of weights) will be preferred, except different owners have equal draw according to weights and second weighted parts of same owner entry receive no consideration over single entries. Failure to draw into race will cancel all fees with the exception of nomination fees. Starters to be named through the entry box by the usual time of closing. A trophy will be awarded to the winning owner. Nominations closed Wednesday, April 10, 2013 with 14.

DISPOSABLEPLEASURE gained terms with the first flight three deep in the opening stages, attending the pace under light rating in the opening half, steadily asserted herself nearing upper stretch to gain the advantage, shifted inwards when roused to gain a clear margin entering upper stretch and held sway to the end under firm left handed encouragement. BRUSHED BY A STAR was rated just out of striking distance tracking the first flight a bit off the inside in the opening half, continued between foes on the second bend briefly awaiting an opening, shifted out four deep nearing the quarter mile marker while being roused to advance, shifted inwards under pressure racing through the stretch while gaining a clear second but couldn't gain terms with the winner. LITTLE MS PROTOCOL broke readily to join the pace outside a rival, attended the pace between foes to the far turn, was urged to dispute the issue while being brushed, then caught in tight quarters leaving the quarter mile marker and lacked the needed final kick while continuing well enough to earn a share. DEVIOUS INTENT moved to the fore soon after the break to dictate the pace on a narrow margin while shifting off the rail, continued in that fashion into the second bend, ducked out nearing the quarter mile marker making some contact with LITTLE MS PROTOCOL and soon gave out. ROYAL LAHAINA settled outside foes from just out of striking distance racing to the backstretch, made brief progress racing four wide through the far turn but steadily faded nearing upper stretch while being fanned five wide into the lane. MAUDE S, reserved along the inside in the opening half, was urged to advance along the rail to lodge a brief bid inside foes racing through the far turn but quickly flattened out entering upper stretch.
