Footnotes

LAST FULL MEASURE was unhurried into stride, came five wide to make her bid, tipped out further to work her away around the field nearing the furlong marker, drifted in despite stern left handed urging and was fully extended to prevail. BYRAMA (GB) settled along the inside, took closer order through the turn, angled out four wide entering the stretch, was blocked near the furlong marker as the winner drifted inward, altered course to the outside, finished full of run once clear but was left with too much to do. JAMAICAN SMOKE set the pressured pace along the inside, kicked clear entering the stretch, but weakened during the drive and settle for the minor award. DRAMA DRAMA was allowed to settle, ranged up five wide through the turn, loomed large with a furlong to run but failed to sustain the drive. QUEEN'S AWARD was unhurried between horses near the tail of the field, responded when roused with three furlongs to run, jammed between horses near the three-sixteenths pole and improved position through the stretch. SHUMOOS tracked the pace between horses, came four wide to make her bid but flattened and faded. HOLIDAY FOR KITTEN settled in hand, shifted out three deep leaving the turn, bid between horses but lacked the needed late response. FANTASY OF FLIGHT pulled to contention four wide, but faltered between horses entering the stretch and retreated. DR. DIAMONDS PRIZE prompted the pace two wide to the final furlong and dropped out. KUNE KUNE (GB) was forwardly placed along the inside, was put in tight entering the stretch, steadied near the three-sixteenths pole and showed little thereafter. The jockey of BYRAMA (GB) lodged an objection against LAST FULL MEASURE for alleged interference near the furlong marker but following the Stewards review there was no change to the order of finish.
