### Footnotes

PLANTATION tracked TUP TAKE' PLEASE while three wide early, cruised up and overtook that rival under the wire the first time, kicked clear nearing five eighths pole, dropped in to set the pace under a light hold, responded to pressure past the quarter pole and held firm. TUP TAKE' PLEASE, unruly behind the gate, broke alertly and set the early pace inside, relinquished command with six furlongs remaining, angled out entering the backstretch, made a slight move three and a half furlongs out, came under strong pressure leaving the far turn and stayed on willingly to be clearly second best. SON OF A BEAR rated in good position early, was ridden along off the rail entering the far turn but lacked any significant stretch response. RUSSELL ROAD settled back early while removed from the inside, was asked for his best while four to five wide leaving the far turn but had no kick. PAGAN CAT saved ground, was put to strong urging mid way on the final turn, eased out for the drive but failed to menace. GOLDEN SET, four wide the first turn, angled in and made some progress after six furlongs then flattened out. SEA RESCUE was outrun.
