MIGHTY BROWN was allowed to settled then rallied three wide on the far turn, was gaining ground and was second best in the en. FLAT GONE was allowed to settled then rallied four wide on the far turn then was gaining ground and was no menace. ROMAN UNBRIDLED was unhurried early then rallied four wide in upper stretch but was no threat in the end. MY KAY SARA was allowed to settled while racing on the inside, was blocked heading into the far turn, angled out to be three wide and was no menace in the en. SOUTHERN BLESSING was allowed to settled while racing two wide on the backstretch then failed to menace. RIVERS RUN DEEP was allowed to settled then raced two wide on the far turn and faltered in the stretch. BURNING WARRIOR set a very fast pace in the early going, drew off on the first turn, was used up and stopped when entering the far turn. SAY CHARLIE was through after a half then stopped.
