STAKES Battle of New Orleans S. Black Type - Thoroughbred

FOR THREE YEAR OLD FILLIES. Free nomination by, Saturday, January 19, \$400 to enter, \$400 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$75,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to starters sixth through ninth. Weight 122 lbs. Non-winners of \$26,000 twice on the turf since October 2, allowed 2lbs, \$18,000 twice on the turf since then, allowed 4 lbs, \$15,000 on the turf since then, allowed 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances). Starters to be named through the entry box at usual time of closing. The maximum field size for the Battle of New Orleans Stakes will be determined by rail setting. Preference to horses with the highest lifetime earnings on the turf. Failure to draw into the race will cancel all fees. A trophy will be presented to the owner of the winner. Closed Saturday, January 19, 2013, with 22 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at 5 and 1/2 Furlongs.) (Rail at 15 feet). COR COR was away well, quickly moved clear, controlled the action while off the rail on the turn, was asked in upper stretch, drifted out near the sixteenths pole and proved much the best while continuing to drift out under urging. GATOR ZONE was urged along on the outside, raced four then three wide on the turn, pursued the winner under a drive and was second best. MY PRINCESS DAWN was urged along while off the pace, raced inside early on the turn, came off the rail outside the quarter-pole and lacked the needed response while able to get the show. SUNSET TIME was away awkwardly, settled at the rear, raced off the rail on the turn, swung four wide into the stretch and failed to threaten. ELLYN'SLITTLESTORM settled while under some urging, went two then three wide on the turn and failed to rally. PRETTYHOTPRINCESS settled on the inside, saved ground on the turn and failed to respond. LIVIN PEACE chased the pace on the outside, raced three then two wide on the turn and tired. TRULY MARIE settled on the outside while under some urging, went three to four wide on the turn, floated five wide into the stretch and was no factor. (Rail at 15 Feet)
