The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. Any horse that competes in both the Alfred G. Vanderbilt Handicap and the Forego will have their entry fee waived for the Forego. Trophies will be presented to the winning owner, trainer and jockey. Closed Saturday, July 20, 2013 with 20 Nominations.

### Footnotes

JUSTIN PHILLIP broke in good order, took up the chase on the embattled pair up ahead from the two path, racing as a team with the runner up, himself hugging the rail, tipped into the three path coming to the quarter pole in preparation for the drive, responded without hesitation and with good energy when asked to, drew alongside the front runners in the vicinity of the three-sixteenths marker and continued to tussle with each of them for the next furlong and a bit beyond, grabbed away the lead for good with a sixteenth remaining, kicked clear, being flashed the whip from the right side for the last few strides. BAHAMIAN SQUALL tracked the duelers while sitting the pocket trip, was under a firm hold for a good portion of the way down the backstretch, but under some hand coaxing speeding around the turn, was put to a strong drive angling outward for the commencement of the stretch run, kept pace with the others, altered course outward a couple of paths at the sixteenth pole, settled into his best stride right afterwards and fought his way past a stubborn pair in the late stages to garner the place. GENTLEMEN'S BET got hooked up in duel with DELAUNAY nearly from the get-go, raced on even terms with that opponent from the rail, with another motivated pair at a slight distance behind, was the first of the two to have the pilot commit to solid encouragement, this occurring a couple of jumps prior to the quarter pole, fell back by a sliver nevertheless, had the winner arrive boldly on the scene by upper stretch, forged on ahead with good courage to re-claim the advantage, relinquished reluctantly to the top one a sixteenth past the furlong marker, then lost out on the place right near the wire. DELAUNAY sparred intensely with GENTLEMEN'S BET from the outside for the opening half, poked a head down in front spinning into the lane and was soon called upon, had the winner make it a three way battle by the three-sixteenths pole, fought with vigor from between rivals from that point before backing away slightly in the last seventy yards. CAIXA ELETRONICA broke with the pack but rapidly dropped back, raced well isolated from the others, under some hand urging to maintain some interest, was already under a drive taking the three path for entrance into the stretch, made no impact.
