STAKES Tropical Park Oaks Listed - Thoroughbred

FILLIES, THREE YEARS OLD. Free nomination by Sunday, December 1. \$1,250 to enter. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. \*(FTBOA offers \$15,000 to the owners of a registered Florida-bred divided \$8,000 to the winner, \$5,000 to second, \$2,000 to third). Weight, 122 lbs. Non-winners of stakes race at a mile or over allowed 2 lbs.; Graded stakes placed or two races other than maiden, claiming or starter or such a race at a mile or over, 4 lbs. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed, then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and One Sixteenth) (Rail at 45 feet).

SEE YOU AROUND (IRE) laid in range in the two path, waited along the rail around the far turn, was coaxed while floating out to the four path in upper stretch, and kicked on to draw past an inner foe. IN OUR TIME set the pace in the two path, waited confidently while just off the rail midway around the far turn, drew clear in upper stretch, but was caught by an outer foe late. DE REGRESO stalked in the three path, was cued two wide midway around the far turn, and chased on from the four path down the lane. YATTA settled in midpack along the inside, floated out to the five path in upper stretch, and finished evenly. BELLE OF RIGHTS bumped with an outer foe at the start, tracked in the two path, was ridden in the three path around the far turn, but was one paced in the six path down the lane. GILDED EDGE raced off the pace in the three path, was driven along the rail around the far turn, but made no impact.

PENDULUM bumped with an inner foe at the start, laid in the back of the pack in the four path, waited in the two path around the far turn before angling out passing the quarter, but did not factor. VICTORIA'S DANCER rated inside but made no closing bid. LIFE'S AN AUDIBLE chased in the three path but faded in the stretch. KALISPERA (IRE) trailed in the four path and never threatened. VIVE VEUVÉ raced wellback in the three path and never menaced.
