### Footnotes

AUDIBLE four wide in pursuit down the backstretch, came under coaxing half a mile from home, continued four to five wide through the turn advancing to issue a challenge swinging three wide into upper stretch, took over straightened away, went clear under a drive kept busy to the finish. CREA'S BKLYN LAW bumped at the start by CALL ME who broke inwards, established the front shortly after and showed the way from the three path widening away down the backstretch and into the turn, came under coaxing nearing the five-sixteenths under growing challenge nearing the quarter pole, swung four wide at the head of the stretch, got displaced straightened away and chased the winner home well clear of the rest and second best. HILLS POND brushed the off side stall at the start, chased five then four wide under coaxing from three furlongs out, went three wide for home, made no impact while up for the show honors. CALL ME broke in at the start bumping CREA'S BKLYN LAW, chased just off the inside under coaxing from the seven-sixteenths, swung four wide at the quarter pole and trailed throughout.
