Footnotes

FRANKIE DOTS stalked the pace inside, bid leaving the seven sixteenths pole, took the lead at the five sixteenths, raced two deep at even terms rounding the far turn, briefly ceded the edge to Honorable Jonas entering the stretch but recovered the advantage mid-stretch, raced briefly clear late yards and lasted well. ACCUSING raced just off the pace in the three path, bid leaving the seven sixteenths pole and dug in to take second the final yards. Very reluctant to load, HONORABLE JONAS quickly took over and moved to the inside to rate the pace, was prompted nearing the three eighths pole, headed toward the five sixteenths, contested the far turn nearest the rail and briefly retook the lead toward the head of the lane then, flattened stride inside the sixteenth pole. OUR CHARITABLE settled off the pace in the two and three paths, bid into the backstretch, rounded the far turn off the rail and had little left. PRIMO PENTIMENTO raced well off the pace and showed little response through the backstretch. DEPUTY DREW mostly saved ground and was not a factor. JOHN DOTHEN settled off the pace in the two and three paths, bid leaving the seven sixteenths pole then flattened stride about the three path of the far turn. SPEEDY A. P. was through early.
