SINGING SARAH broke alertly to be forwardly placed then lacked a rally and held third. LADY OF THE EMPIRE failed to menace with a mild stretch bid. INSPIRE ME lacked a rally. COURAGEOUS LYNNE was outrun. DROPS AND BUCKETS was no factor. ESTRELLA GRANDE raced in close pursuit then tired. LULU'S ON THE MOVE was no factor. ADULT IN THE ROOM showed little.
