CALEB'S A SURVIVOR Contested the lead off the rail, responded to kick clear in the lane and was under pressure for the win. STRUEVES STAR Broke a step slow, in hand along the two path, took the rail on the final turn, eased out and closed well. EX EX EX Slammed at the start by BIGSHOTINTHENEWS, rushed out to contest the lead along the three path into the backstretch, two path around the last turn and weakened. BIGSHOTINTHENEWS Slammed into EX EX EX at the start, four wide into the backstretch, three path after that, two from the rail around the final bend and weakened. MCMULLEN COUNTY Broke sluggishly, saved ground around he turns and weakened. FIELDING GOLD In hand along the three path into the backstretch, continued on that path to the lane and tired.
