Footnotes

COUSIN TINO pressed early pace, challenged CREST OF EDEN for the lead at three eighths pole, held slight edge and brushed by BAKELITE top stretch then brushed back into rival shortly after, took on added challengers in final furlong, refused to be denied, dug in tenaciously from inside position and held nose over rival on the wire. BAKELITE stalked between in second flight then made move for lead at the quarter pole, duelled with COUSIN TINO top stretch, continued to battle brushing with rival, put up strong fight just got nipped on the wire. CHIEF WHITE SOX stalked inside of duo, angled out upper stretch and moved up to duel three wide in late drive, lacked final kick to get by. JUDGE HUDSON was rated midpack in early stages, sent driving into stretch, drifted wide then duelled in deep stretch just lacked closing kick to get by. BRANDT raced near the back then hustled up racing wide entering the lane, improved position without threatening late leaders. CREST OF EDEN set pressured pace then duelled with winner three furlongs out, rival held slim lead but kept on stubbornly into upper stretch then gaveway in final furlong. D'ROCK raced off the pace, saved ground near the inside then angled out and failed to threaten. GRAN NETWORK was off slow then remained slow into strides, trailed far back and gained mild amount of ground late. KING NEPHRITE raced off the pace and widest through the backstretch, sent two to three wide into stretch without gaining in the lane. DAVIDS BOY raced three wide in the second flight then failed to sustain bid in far turn.
