CANDY MY BOY pressed the pace in the three path, bid at the three-eighths pole, dueled inside of a foe in the stretch and then drew off under steady urging. ESPOSITO stalked the pace in the two path, bid on the turn, dueled, then was no match late. SPIRIT OF CALEDON stalked the pace in the three

path, then was no threat. ONE KIND OF CRAZY improved position late in the four path. HARD WORK raced in the three path, then faded in the stretch. JUSTENUFFTUFF was steadied at the start and the seven-eighths pole, then raced in the four path. STAR DOG improved position late outside. AVIATOR PARKS was checked at the seven-eighths pole in tight quarters. DIAMONDMAZE led in the two path to the far turn. JOEY B stalked the pace in the four path before fading. D'URBAN PARK stalked the pace in the five path for a half mile.
