BIG HOUSE was bumped at the start, opened a clear lead soon after, raced three-wide while setting the pace, was well rated through the back-stretch and held sway to the wire. VENTURA HIGHWAY was reserved just off the leaders early, raced four-wide through the second turn, reached a striking position in mid-stretch but failed to gain on the winner in the drive. CATTLE DRIVE broke awkwardly and was bumped, chased the winner while racing three-wide and gave way gradually in the drive. SNOOP was off a step slow, lacked early foot, raced four-wide through the second turn and was not a factor. TRANSCENDENT chased the winner from the inside for five furlongs and weakened. BRAVE REQUEST lagged throughout.
