ALL KNIGHT set the pace off the rail, responded when RULE NUMBER SIX came to him in midstretch, then was all out to prevail. RULE NUMBER SIX rated off the pace, advanced along the inside around the far turn, angled out for the stretch run and made a run to reach ALL KNIGHT in midstretch but couldn't sustain his bid. MEGAMOVE reserved off the pace, advanced three wide around the far turn to loom a threat in the stretch but didn't do enough late. GIBSON COUNTY LINE taken in hand early, raced four wide around the far turn and had no response when asked. BUZZ THE DEPUTY chased the pace off the rail into the far turn, then tired. PICO BOLIVAR was outrun. CONCORDE EXPRESS showed early foot and faded.
