TIME TO HONOR had the best speed, set all the pace to the stretch then responded when set down for the drive and held under steady urging. DANCE CHIEF was four wide to the backstretch, tracked the leader to the second turn, offered his best bid three wide to the stretch but could not make an impact late while saving the place. UNVARNISHED had no speed, settled to the half, was asked for more three wide on the second turn, advanced into contention into the stretch but could not sustain the needed response. VICTORY TRAIL stalked the pace from the rail to the half, dropped back some while still inside rivals on the second turn then went evenly in the drive. OHMYOHMY prompted the pace to the half mile pole, saved ground and made a bid on the second turn to loom a factor into the stretch but lost his punch in the final furlong. I AM THOR pressed the pace from off the rail for six furlongs then weakened in the stretch. WINNING VOW had no speed, offered his best rally while circling four wide on the second turn then gave way in the lane.
