Footnotes

RODGERSON tracked the pacesetter in early stages, made a bid for MORNIN BREW heading into far turn, began to vie for lead along outside, shook free midstretch, continued to dig in and held off rivals at the wire. WINTER'S FURY was allowed to settle along rail in early stages, inched up a bit closer nearing far turn, asked to pick up pace in upper stretch and gained ground three wide in the late drive. AVENGED stalked along inside in early stages, began to advance position along rail in the turn, lacked racing room in upper stretch, angled out, slightly gained ground, angled back in and lacked final kick to make serious impact. MAJESTIC MAN saved ground along inside in early stages, angled out and slightly gained position in the stretch. HORVAT CLAN reserved in early stages racing in back of the pack, continued along rail in backstretch, slightly gained position nearing far turn but failed to make impact in stretch. MORNIN BREW took command in opening quarter, continued to set pace along inside in backstretch, challenged by RODGERSON heading into far turn, vied briefly but could not keep up pace and steadily weakened in the drive. TOUCHED THE CLOUDS raced three wide in the first turn, continued to stalked two to three off inside and steadily began to weaken after a half mile. RULE NUMBER SIX tracked the top two pacesetters in backstretch, raced three wide into the lane and could not keep up pace in the stretch. BUZZ THE DEPUTY raced four wide into first turn, paced back to last after half mile and lacked response in the drive.
