LET'S CALL A TRUCE broke slow, was unhurried into stride, responded when roused on the second turn, circled seven wide into the stretch, finished full of run, engulfed the leaders inside the sixteenth pole and edged clear. HURRY UP ALAN settled in hand, ranged into striking distance between horses, forged command leaving the second turn, continued on well but was no match for the winner late. RULE NUMBER SIX was allowed to settle, closed the gap between horses, angled out entering the stretch to make a bold bid but flattened between horses late. GAELICO pulled to contention three wide, gained command after a half, disputed the issue to the stretch, but weakened during the drive. LOGAN STREET was allowed to settle, got through toward the inside and improved position. FOREVER CONGA was allowed to settle, came five wide and finished with a mild rally. DEFENSE MODE failed to respond. AMBER COAST attended the pace along the inside, garnered a brief lead, but came up empty after six furlongs and dropped out. SPOOKY KITTEN vied for the lead between horses to the second turn and retreated. DEPARTURES pressed the pace three wide for a half and stopped.
