Any horse that has placed in a graded sweepstake will have their entry fee waived and any horse that competes in both the Jim Dandy and Travers will have their entry fee waived for the Travers. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 123 lbs. Non-winners of a Grade 1 in 2013 allowed 2 lbs.; a Grade 2 over a mile in 2013, 4 lbs.; a Graded Sweepstake at a mile or over, 6 lbs. Footnotes

PALACE MALICE broke alertly and assumed a forward position in short order, patiently prompted the pacesetter from the two path until the end of the backstretch, moved up when ready leaving the half mile pole and latched on to MORENO before reaching the midway point, continued on nearly even terms the rest of the way to the quarter pole, shadowed that rival outward to be in the three path entering the stretch, got called upon almost simultaneously with the chief nemesis, won the fight through the furlong grounds to arrive at the eighth pole first, held a healthier margin than the final one prior to getting geared down late and crossing the wire under light hand urging. WILL TAKE CHARGE settled into midpack from off the inside, was already under encouragement spinning into the lane, closed in with good energy en route for the place, not being asked for his best same as the winner in the very late stages. MORENO broke on top and maintained control, was rated along kept at a slight distance from off the inside while showing the way, with the top one in close attendance to his outside, had that opponent increase his presence departing the backstretch and rapidly hitch up, continued onward as a team clutching a narrow advantage, got set down entering the stretch having drifted into the two path, yielded before completing the ensuing furlong, lugged inward from right handed stick work at the eighth pole, fell back steadily thereafter undergoing an erratic course, both in reaction to and not in reaction to whichever side an intermittent whip was being applied. BASHAAR saved ground to the five-sixteenths marker, was two to three wide by the head of the stretch, mustered up a mild response to get up for the last major check. CODE WEST loosely pocketed, got eased into the two path shortly past the half mile pole, was under a drive less than a quarter later, made no impact. LOOKING COOL worked out a tuck on the rail coming to the beginning of the backstretch, failed to menace

off the subsequent ground-saving journey. PERFECT TITLE lagged behind at the back of the pack, was asked to pick up the pace at the half mile pole, swung three wide into the stretch, had little left to offer. MYLUTE well reserved in the initial stages, was put four wide at the top of the lane, came up empty. FREEDOM CHILD off the inside throughout, swung five wide into the stretch, made no headway and tired.
