**Footnotes**

SPOOK EXPRESS (SAF) unhurried early, saved ground while advancing into the stretch, angled outside the leaders in midstretch and rallied under pressure to be up in time. GAVIOLA quickly moved to the fore, made the pace along the inside into the stretch, came off the hedge a bit for the drive and continued on gamely while being edged late. WINDSONG allowed to settle, angled to the hedge at the top of the stretch and was gaining slowly at the finish. SOLVIG chased the pace along the inside into the stretch but didn't do enough late. LADY DORA well placed into the far turn, raced three wide around the far turn and had no response when asked in the drive. TIPPITY WITCH failed to menace. ORANGE SUNSET (IRE) was outrun while racing three wide. MEGANS BLUFF chased the pace and tired.
