STAKES Honey Fox S. Grade 2 - Thoroughbred

FOR FILLIES AND MARES, FOUR YEAR OLDS AND UPWARD. (\$15,000 bonus for FTBOA Registered Florida-Bred by an FTBOA Registered Florida Sire). Free nomination, \$1,000 to pass the entry box and \$1,000 additional to start, with \$200,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$120,000, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to sixth. Weight: 123 lbs. Non-winners of a grade I or II stakes at a mile or over on the turf since November 1, allowed 2 lbs.; of a graded stakes at a mile or over on the turf since October 1, 4 lbs.; \$45,000 at a mile or over since October 1, 6 lbs. In the event this stakes is taken off the turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. Closed Saturday, March 1, 2014 with 40 Nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile) (Rail at 72 feet).

CENTRE COURT broke through the gate prior to the start, was reserved off the pace, raced four wide around the far turn, was fanned even wider entering the stretch, then rallied to take over late and just lasted over KITTEN'S POINT. The latter, unhurried early, swung out widest of all for the stretch run and rallied to just miss. EFFIE TRINKET vied for the lead along the rail into the stretch, responded when CENTRE COURT came to her, then gave way late. TRIPLE CHARM (GB) steadied in the early going, stalked the pace into the stretch and lacked a rally. TAPICAT reserved racing along the inside, advanced to loom a threat in the stretch, then weakened. PARRANDA stalked the pace three wide to nearing the stretch, then tired. TRIPLE ARCH vied for the lead outside EFFIE TRINKET to the top of the stretch, then faltered. RUN A RISK chased the pace into the far turn and faded.
