

Footnotes

CLUBHOUSE RIDE bumped and forced inward at the start to be away slowly, settled inside, angled out, rushed up rapidly while three wide then along the rail, surged inside pacesetter to grab command leaving backstretch, kicked clear and scored convincingly under steady right hand pressure. ROAD READY gained good position from off the rail, prompted the pace three wide, was hard asked to stay in contact of winner on the final winner and gamely lasted for the place. WEALTHY AVIATOR unhurried while securing the inside, chased along the rail to final bend, advanced and rallied inside rivals in upper stretch, then angled out and found his best stride late. PHANTOM LOVER three wide early, remained well off the rail stalking the pace, caught four wide around the final bend and into the lane and went evenly to the wire. CASH MICHAEL three wide early, shifted over, chased from the inside, angled back out some, came three wide into the stretch and failed to menace. HOLLYWOOD HEIST was bumped early, stalked from off the rail then three wide and later between foes and went evenly to the wire. WAR PILOT broke inward and bumped winner,settled well off the pace, chased along the inside, shifted out, came four wide into the lane and drifted out further in the drive. INCLUDING GOLD bumped early, chased three wide then outside foe, came four wide into the stretch and finished on the far outside. BLINGBOY sped to the front while crossing over, set the pace while slightly off the rail, had no answer for the winner into the final bend and weakened on same path.
