SUNNY DESERT got tuned slightly sideways after making contact with MOM'S LAW soon after the start, took up residence in the two path and set the splits, while being rated on a loosely-contested lead, began to draw away from the others during the later stages of the run around the bend, still unasked for speed, entered the stretch and only then got asked for a response, lengthened away, got geared down for the final sixteenth once the verdict no longer seemed to be in doubt. I BET TONI KNOWS rode the rail for the initial three-quarters, angled into the three path coming into the stretch to be outside the leader, proved no match. SHESABRONXBOMBER saved ground and lacked the necessary stretch response. MISCHIEF MAKER four wide at the three-eighths pole, tired. LEMON SPLENDOR lunged inward at the start, went on to grab a forward position, was three wide and already under encouragement by midpoint on the turn, folded. WHY TAKE A CHANCE coaxed in the two path while chasing the top one, gave way. MOM'S LAW bumped with the winner after the start, never reached contention.
