PAVED IN GOLD broke alertly and showed in front along the inside while under a stout hold, dictated the pace while well in hand, dug in gamely when set down for the drive and got the job done while drifting a bit through the stretch. BLUSHING DEED, rated along outside, advanced three wide on the turn and finished gamely from the outside. PAULA'S GIRL prompted the pace while in hand then was steadied from between rivals in the stretch. TAP YOUR HEELS raced inside and had no rally. HERE I GO raced between rivals early, was taken widest entering the stretch but had no response when roused. Following a claim of foul by the rider of the third place finisher against the winner for interference in the stretch, the result was declared official.
